### STEPS TO COMPLETE YOUR LIVE CLASSROOM PROGRAM

#### 1. REGISTER FOR CLASS

- Before registering please have this form and your Driver's License Number ready. Any information in the above box that is not clear or incomplete should be verified at [www.epay18thjudicial.org](http://www.epay18thjudicial.org) prior to registration. You will need to call the Traffic Court Clerk at (630) 407-8600 if the type of class is not indicated.
- Call (630) 665-6530 right away or register via [www.DuPageDriverSchool.com](http://www.DuPageDriverSchool.com). **CLASSES ARE LIMITED AND FILL UP FAST.** Early registrants will be offered a greater selection of dates for classes. Phone registration hours are 9:00 AM to 4:30 PM, Monday through Friday.
- Attitudinal Dynamics (English) is held on Saturdays from 9:00 AM to 3:30 PM while Defensive Driving (English and Spanish) and Attitudinal Dynamics (Spanish) are held on consecutive Monday and Tuesday evenings from 6:00 PM to 9:00 PM.
- The fee for the live course is \$95.00. Payment may be made by a major credit or debit card, cash or money order payable to "Driver Improvement School" no less than seven (7) days before the date of the scheduled class. **Personal checks will not be accepted.** Your registration fee for class is separate from any fines or fees assessed by the court. If paying by Credit card, it will appear on your statement as payable to the DuPage County Bar Association, who administers the class. Class fees are subject to change without notice.

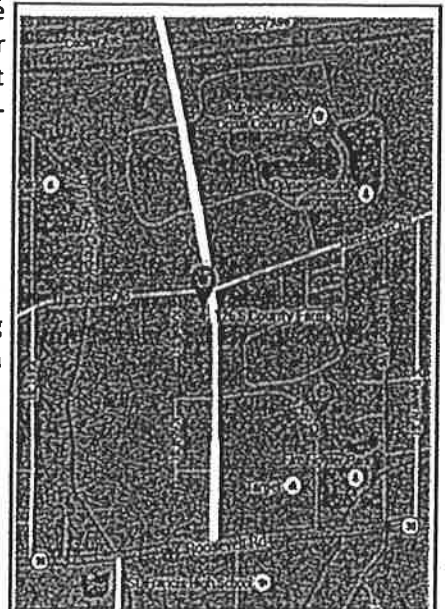
Do not contact the Clerk of the Court regarding dates and times of Driver Improvement School.

#### 2. ATTEND CLASS

- You must arrive at least 15 minutes early for your class. The doors to the building are locked at class time and no one will be admitted who is not in the building on time.
- Bring a photo ID and pen or pencil.
- If you fail to attend class on the date and time assigned, you will be charged a \$35.00 rescheduling fee. Rescheduling a class can be done by phone only.
- You will receive a certificate of completion which you should take with you to court on your return date. The court clerk will also be notified of your successful completion of the class and the information will be added to your court record.

#### 3. RETURN TO COURT

- Complete the DuPage County Bar Association Driver Improvement School before the end of your supervision term. If you did not complete the required class during this term, you will need to go back to court and ask for an extension.
- Comply with all laws of any jurisdiction while on Court supervision. If you fail to comply with all terms of your supervision, the Court will be notified and a bench warrant may be issued for your arrest.

## ONLINE DRIVER IMPROVEMENT SCHOOL - DEFENSIVE DRIVING ONLY

Note: These instructions are for the Online Version of Defensive Driving which is available to you **ONLY** if your Court supervision assignment on page 1 of this form has been marked for the option, "C) Online Version Of Defensive Driving Allowed: \_\_\_\_\_".

*If you are unable to register online, you may register by phone Monday – Friday, 9:00 AM – 4:30 PM at (630) 665-6530. Have this form, your Driver's License Number, your credit or debit card and a valid email address ready when you register.*

### 1. REGISTER FOR THE ONLINE CLASS

- a. Before registering, please have this form and your Driver's License Number ready. Any information noted in the box on the other side that is not clear or incomplete should be verified at [www.epay18thjudicial.org](http://www.epay18thjudicial.org) prior to registration. You will need to call the Traffic Court Clerk at (630) 407-8600 if the type of class is not indicated.
- b. To ensure that you complete the online class in time to satisfy your Court Supervision, we strongly suggest that you register at least 30 days before you return to court.
- c. To begin your registration, go to [www.DuPageDriverSchool.com](http://www.DuPageDriverSchool.com). Click on the blue button that reads "Register for DDC6 online class". You will be required to make payment by debit or credit card to receive your access code. (Visa, MasterCard, Discover, American Express or PayPal account are accepted. Note that your credit card statement will show DuPage Driver School or DuPage County Bar Association.)
- d. The fee for the online course is \$95.00 and must be paid in full before you will receive your Access Code. Payment may also be made by cash or money order payable to "Driver Improvement School" in person at the address below Monday – Friday, 9:00 am – 4:30 pm. Personal checks will not be accepted. Your registration fee for this class is separate from any fines or fees assessed by the court. Class fees are subject to change without notice.

### 2. COMPLETE THE ONLINE CLASS

- a. You must complete the course at least 3 days prior to your assigned court date. The online class requires 4 – 5 hours of computer time, and your successful completion requires that you achieve an 80% or higher score on the final test.
- b. Once you receive your Access Code, log onto the online class anytime of day or night at [www.safetyserve.com/dcba](http://www.safetyserve.com/dcba). After initial login to the school site, we strongly suggest you complete the class within 30 days.
- c. If you do not begin the course immediately after purchase or if you save your progress on the course and finish it at a later time, be sure to login to the course site as a returning student to prevent an error message.
- d. Please note that upon completion of the online class, you will see an option to print a receipt copy of your certificate of completion. You must print out this certificate and take it with you to court. The Court Clerk's office will be notified of your score and will add it to your court record. The judge will receive a report of your completion on your return date.
- e. It is your responsibility to complete the course within 30 days of initial logon, to enter all your information accurately and to complete the course at least 3 days prior to your court date so that the court will receive notification of your completion.
- f. If you determine that a live class was required after the purchased access code has been used, the full \$95 fee will be charged to reschedule to a classroom version.

### 3. COMPLETE THE TERM OF YOUR COURT SUPERVISION & RETURN TO COURT

- a. Complete the DuPage County Bar Association Driver Improvement School class before the end of your supervision term.
- b. Comply with all laws of any jurisdiction while on Court supervision.

If you fail to comply with all terms of your supervision, the court will be notified and a bench warrant may be issued for your arrest.
